Fund Objective

The Fund aims to achieve long term growth on your investment by investing at least 80% of its assets in the equities and investments similar to equities of companies worldwide. The Fund may invest up to 20% of its assets in emerging markets (developing countries). The Fund is actively managed with reference to the MSCI ACWI (USD) - Net Returns (the Index) which it seeks to outperform by 2% over the medium to long term. Russell Investments/ Money Managers have full discretion to select investments for the Fund. This product is an Article 8 product, as defined under EU regulation - it promotes environmental or social characteristics and invests in companies that follow good governance practices. This product does not have sustainable investment as its objective.

Fund Update

The Fund outperformed the benchmark return, benefitting from strong stock selection. Factor impacts were modest in the period. At the sector level, overweight exposure to and stock selection within materials was the main positive contributor, notably an off-benchmark position in AngloGold Ashanti and an overweight to Zijin Mining Group. An overweight to and stock selection within communication services was also rewarded (overweight Alphabet). In industrials, although an overweight to the sector was unhelpful stock selection was positive (overweight Contemporary Amperex Technology). On the negative side, an underweight to and stock selection within technology detracted (underweight Apple, Nvidia). An underweight to Tesla in consumer discretionary was also unhelpful.
