

## Interest Accumulator ARGUS GUARANTEED ACCOUNT

#### Investment Objective

The objective of this account is complete security of principal. The account earns a set rate of return whilst allowing no downward movements in the value of the capital invested (ignoring any potential effects of inflation). In this respect, it is very similar to a bank deposit.

#### Risk and Return Profile

This Account targets a stable return profile with no price fluctuations. The declared interest rate is guaranteed by the Argus Group. To support this guarantee, the underlying investments within the portfolio include short-term, high grade bonds and local mortgages.

Argus declares the rates each month and they are based on the underlying investments. These rates are guaranteed for either one or five years depending on which account period is chosen by the pension member.\* Interest is credited daily.

- Extremely risk averse and uncomfortable with investments that fluctuate in value
